

3. Mr. Prem Chandy aged about 39 years s/o John Chandy by caste Christian, by occupation business, resident of D-305, Tereskova Path, Sector-2B, Bidhannagar, Durgapur-12, Ps. Newtownship, Dist:- Burdwan , hereinafter jointly referred to as Trustees" (which expression shall , unless excluded by or repugnant to the context hereof , be deemed to include their heirs , executors, administrators and representatives) of the OTHER PART.

Whereas the Settlor is desirous of establishing a Trust for public charitable objects and for establishing Educational institutions and training centers at Ukhra under Durgapur Sub-Division and also in the country for imparting school education, medical , engineering, professional and general education with the objectives as stated hereunder. And whereas the settlor himself and the other trustees have , at the request of the settlor , agreed to act as the first trustees of these presents as testified by their being parties to and executing these presents.

And whereas, it is necessary to declare the objects and terms of the Educational and Public Charitable Trust, being continued under these presents.

Now this Indenture witness as follows:-

1. That in order to effectuate his aforesaid desire , the settlor has set apart and handed over and assigned to the trustees , a sum of Rs. 10,000/- (Ten Thousand only) (hereinafter called as the "Trust Fund") and further gifts and donations etc. that may be received by the said trustees from time to time, all accretions, additions and accumulated income thereto and all other properties that may be acquired out of the same or are subject to the said trust for the objects and purposes hereinafter contained with the terms, conditions and stipulations hereinafter declared or which may be acquired by the trustees or may come to these hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents and the trustees shall hold and stand possessed of the same upon the trust subject to the powers , provisions, agreements and declarations herein after contained. No immovable properties are hereby given to the Trust.
2. That the Trust so formed will be known as" **ST. STEPHENS EDUCATIONAL AND CHERITABLE TRUST**" and will have its office for the present at St. Stephens Model School, Station More, Ukhra, Post-Ukhra, Ps. Andal, Dist. Burdwan and in future the office of the trust will be situated at such other place or places as the trustees may decide from time to time. The area of activities of the trust will be the whole of India.
3. The settler does hereby grant, transfer and assign unto the trustees the said trust fund to have and fund upon the trust and the trustees shall hold and possess the

said trust fund upon trust to receive all interest, dividends, rents, gains and other income thereof and there about and in the first place to reimburse them or pay and discharge all costs, charges and expenses or of incidental to and necessary for the management or administration or execution of the trust and also all outgoing, rates, assessments, dues, duties, levies, imports and other taxes payable in respect thereof.

4. Objects of the trust:

The Trust shall have the following objects:

- (i) To establish, run and administer or cause to be established and administered Schools, educational institutions, institutes on vocational education, B. Ed. colleges, industrial education, industrial training institute etc. for the purpose of the spread of education and for creation of centre of excellence and to get education institutions registered with the registering authorities throughout the country in compliance of laws and rules of Government authorities.
- (ii) To establish, run and administer hostel for students, appoint teachers and other working professionals for running the educational institutions, obtain affiliations of the courses and degrees from U.G.C./ Universities of the country.
- (iii) To cause sanctions of various funds from various financial aids authorities of the government and other benevolent N.G.O.
- (iv) To extend medical facilities in diverse possible ways even by arranging free medical camps for the poor establishing and running dispensaries and hospitals.
- (v) To work for education, upliftment of the weaker section of the societies in diverse possible ways.
- (vi) To promote literacy among all age group of women by imparting training and undertake mass programme of functional literacy which will aid and assist the object of the society.
- (vii) To support, donate, contribute, subscribe, pay in cash and/or give in kind for educational, social and charitable purpose to any public institution, trust or society for any purpose that may directly or indirectly further the objects of the trust.
- (viii) To provide scholar ships for deserving students that may directly or indirectly further the objects of the trust.
- (ix) To promote fellowship, social and cultural relationship among people at large.
- (x) To undertake rural development programme and/ or engage in rural development activities to meet the objects of the trust.
- (xi) To undertake activities of every nature to preserve environment and protect it from pollution.
- (xii) To work in collaboration with Government or quasi government organization, charitable or social institutions/associations in furthering the common objects of the trust.
- (xiii) And generally to do all acts and things as may appear to the trustees in their discretion to any other purpose as may be found proper.

- (xiv) To impart education with the emphasis of education with modern technologies and all round development of children.
- (xv) To cause sanctions of various funds from various financial aids authorities of the government and other benevolent N.G.O.
- (xvi) To arrange and organize lectures, debates, discussions, seminars and excursions for the diffusion of knowledge.
- (xvii) To promote and encourage advancement of literacy, cultural, religious, scientific and technical education among the youths of the area.
- (xviii) To help the weaker section of the society to eliminate their various problems relating to health, education, nutritious food, population growth, medical treatment, shelter, clothes, etc. by not only providing financial help but also through various prevention & awareness programmes.
- (xix) To provide relief at the time of natural calamities such as floods, earthquake, draughts, etc.
- (xx) To establish various training centers for imparting academic and technical knowledge for the improvement of business and non- business activities.
- (xxi) To encourage the local inhabitants by providing training to physically handicapped youths.
- (xxii) To do all such activity necessary for the control and prevention of all kind of polluting problems of India at large.
- (xxiii) To open and maintain charitable dispensaries, children's clinic, arrange for blood - donation and eye camp etc.
- (xxiv) To encourage the advancement of international understanding, goodwill and peace through the spirit of co-operation.
- (xxv) To make arrangement for raising loan from any Bank/Banks, Financial Institutions in the name of the Trust for the development of the Trust.
- (xxvi) To acquire land, buildings and other necessary fixed assets such as furniture etc. either on ownership basis or on leasehold basis or any other mode this is necessary for the achievement of the object of the trust.
- (xxvii) To follow the provisions of the Income Tax Act, 1961 in particular for investment, donation and loan acceptance and / or repayment.
- (xxviii) To do all such acts, deeds, matters and things those may be deemed incidental or conducive to activate the forgoing objects.

5. Powers of the trust:

To carry out the objects the trust shall have the following powers:

- (i) To collect, raise, receive and accept subscriptions, donations, grants, gifts in cash and/or in kind for all or any of the objects of the trust.
 - (ii) To draw, accept, make, endorse, discount and negotiate bills of exchange, promissory notes and other negotiable instruments.
 - (iii) To trade teaching and learning materials, arrange for shows and utilized the sale proceeds to develop the object of the trust.
 - (iv) To purchase, take on lease or otherwise acquire any property, land and building.
 - (v) To do all other acts, deeds and things as are incidental or conducive to the attainment of the objects of the Trust.
6. The income and properties of the trust whatsoever derived or obtained shall be applied solely towards the promotions of the object of the trust and no part thereof shall be paid to and divide amongst any it's trustees by way of profits.

And generally to do all such acts and things that may appear to the trustees in their absolute discretions to any other purpose as may be found proper. Thereby to say that the trustees will be at liberty to do all acts for the protections, , preservations, verifications, transmission, conveyance and to do all ministerial jobs whatsoever may be necessary in all time to come.

7. Application of profits, income and property of the trust:

The profits, income and property of the trust will be applied safely for the promotion of the objects of the trust and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonuses or otherwise howsoever by way of profits to any member.

Provided however that nothing herein contained shall prevent in good faith the payment of remuneration of officer or servant or employee of the trust or other persons including the trustees hereof in return of any services to the trust.

8. Controlling power of funds and assets:

The funds and assets of the trust shall be controlled and managed by the board of trustees and the decision of the trustees to that effect shall be final. .

9. The accounting year of the trust will start from April and will end on 31st day of March of each year. The trust account will be audited by duly qualified auditor if its total receipts exceeds Rs. 50,000/-. The trust fund will be invested as per provisions u/s 11(5) of I.T.Act 1961 as and when amended.

10. Powers of the Board of Trustees:

That the furtherance of the objects of the trust, the trustees shall have the following powers:

All properties, movable and immovable, belonging to the Trust shall vest on the Board of Trustees and the Board of Trustees shall have the control and management of the fund and income of the Trust. Without prejudice to the provisions aforesaid, the Board of Trustees shall have the following powers:

- i) To preserve and keep in a proper state of repairs the properties owned by the trust.
- ii) To pay municipal and other dues in respect of the properties belonging to the trust.
- iii) To purchase, take on lease or otherwise acquire any property, movable or immovable, for the trust.
- iv) To sell or let out any of the properties belonging to the trust.
- v) To invest money of the trust in such manner as the Board may think fit and proper, subject, however, to the guidelines provided in this respect from time to time under the Income Tax Act, 1961 or any other law for the time being in force.
- vi) To sign, sale, execute, deliver and register according to law all transfers, sale deeds, conveyances, assurance, reconveyances, lease, mortgage, charges and other documents vested in them.
- vii) To sign and seal the final accounts of the trust and all other documents and/or papers as may be required to be signed and sealed for submission thereof in compliance with any statutory obligation including documents and/or papers relating to registration of the said trust before the Income Tax Authorities under section 12A of the Income Tax Act, 1961 and making application for grant of

approval of the trust under section 80G(5)(VI) of the said Act and submission of annual return before the Income Tax Authorities.

- viii) To make and alter rules for its meeting and other matters relating to it.
- ix) To prepare service rules as regards the employees of the trust.
- x) To place from time to time at the disposal of the Executive Committee such sum as it may think fit and proper to meet expenses necessary in discharging functions.
- xi) To accept any donations, contributions, grant in cash or in kind, from any persons (s) body of persons, entities, industry house, organization, Society, corporate house, Institutions or trust from India or abroad with or without conditions.
- xii) To apply the whole any part of the income of the trust or the trust fund or accumulation thereto, to any one or more of the objects of the trust, as the trustee may, in their discretion deem fit from time to time.
- xiii) To invest the trust fund either in the purpose of mortgage of immovable property or in the share , stock and debentures or other securities and investments, or in deposits with or loans to any company , bank, firm or any other person and to alter, vary or transpose such investments from time to time at the discretion of the trustees.
- xiv) To borrow money from financial institutions or banks in the name of the trust with or without providing security for development of the trust.
- xv) To sell, dispose of, alienate or otherwise deal with any property comprising the trust fund
- xvi) To let out, lease, demise any immovable property comprised in the trust fund for such period and at such rent; on such terms and conditions as the trustees in their discretion may think fit and proper.
- xvii) To open Bank account in the name of the Trust with any bank or banks , to operate such account and to give instructions to the bank for operation of such account jointly by President and Secretary of the trust or by an agent appointed by the Trustees.
- xviii) To raise loan of such amount from any Bank/Banks in the name of the trust and for the interest of the trust by giving collateral security/other security of the trust as may be decided by the trustees in the meeting of the trust.
- xix) To adjust, settle, compromise, compound, and refer to arbitration all actions, suits, claims, demands and proceedings regarding the Trust Fund.
- xx) To appoint constituted attorney and agent and to delegate to such attorney or agent all or any of the powers vested on them under these presents and from time to time remove such attorney or agent and to appoint other or others in his or their place.
- xxi) To appoint or make provision for the appointment of any person (including all or any of the Trustees or administrators or managing Trustee / Managing Trustees or otherwise for the purpose of administration of the trust in such manner and subject to such rules and regulations as the Trustees may prescribe and also to appoint and provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this deed in such manner and subject to such Rules and regulations as the trustees may time to time think fit and proper.
- xxii) To make , vary, alter or modify schemes , rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and /or running any institutions in furtherance of the objects of the trust and otherwise for giving effect to the objects of the Trust.

- xxiii) To start, abolish, discontinue or restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscriptions or donation made by them.
- xxiv) To set apart and / or allocate the whole or a part of the income or the corpus of the Trust fund or part thereof for any of the objects of the Trust.
- xxv) To take over, Purchase, acquire, manage, control other charitable trust, society, institutions, association or their assets/ liabilities or to join, co-operate or amalgamate this trust or its assets/ liabilities with other or others having similar or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this trust.
- xxvi) To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceeding or disputes, claim, demand or things as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- xxvii) To borrow money either on the security of any property comprised in the trust fund or otherwise for all or any of the purpose of these presents, and it shall be lawful for the trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- xxviii) To apply to the Government, public bodies, corporations, companies or any persons of India or abroad, for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trusts and to discuss and negotiate with the Government Departments, public and other bodies corporations , companies and persons scheme , project and other work and matters within the objects of the Trust and to confirm to any proper condition upon which such grants and other payments may be made.
- xxix) To transfer and hand - over this Trust to any other society , corporation , institutions , Trust of organizations on such terms and conditions as the trustees shall in their absolute discretion think fit and proper to be held by the society , Corporation, Institutions, Trust of organization with the powers , provisions , agreements and declarations , appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust Fund . The trustees for the time being of these presents shall become discharged from the trust hereof relating to trust funds so transferred.

11. Manner of holding board meeting of the trustees:

The meeting of the board of trustees may be called at any time by the President. Normally the President of the board will be the Chairperson of the meeting of the Board. In absence of the President, the Vice-President shall act as the Chairperson of the meeting. The quorum for any meeting of the board of trustees shall be three. The board of trustees shall act by a majority decision. Where the trustees are equally divided, the matters will be decided by a casting vote of the Chairperson of the meeting.

12. The trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a trustee shall not be answerable or accountable for neglect, default, acts or omissions or commissions of the other

Trustees, nor any bankers or others persons with whom the trust properties or any securities may have been deposited or kept.

13. The trustees will not be entitled to receive any remuneration, but the trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
14. The number of trustees shall not be less than three and not more than twelve. If the number of the trustees falls below three, the remaining trustee shall not act except for the filling up of vacancy; so long the number is below the said minimum number.

15. The Board of Trustees will be nominated & constituted as follows:-

16. That all the members of the Board of Trustees will be treated as the first member of the Trust and the office of the trustees' ifsofacto becomes vacant on the happening of the following:

- (a) Death, (b) Insolvency, (c) Voluntary resignation subject to acceptance of the board of trustees, (d) On being rendered incapable to perform duties due to old age or continuous illness, (e) On being convicted of any offence involving moral turpitude, (f) On being failure to attend four consecutive meeting of the board of trustees without any sufficient cause or assigning any reason, (g) On being adjudicated as insolvent by competent court of law, (h) On being removed by the majority members of the board of trustees. That in case of death/renunciation of any member of the trustees, the Board of Trustees will adopt and admit a new member by majority of decision within three months from the death of such death or renunciation of the member.

17. A member of a trust shall cease to be its membership as a trustee of the Trust in the following situations:-

- (a) If he without leave of absence or without assigning any reason does not attend three consecutive meeting of the Trust Board in one calendar year.
- (b) If he is declared insolvent declared by a competent court of law.
- (c) If he is convicted in any criminal offence by any court of law
- (d) If he/she is involved in any act which affects his/her moral turpitude and which is found detrimental to the interest of the Trust.
- (e) If any of the above reason, $2/3^{\text{rd}}$ members of the Trust Board can remove such member from the Trust Board through the process of impeachment taken suo-moto by the President and in that circumstances such member either resigns voluntarily from the Board as Trustee or he may be removed by the President exercising his own power.

18. The settler or any trustee of the trust will be at liberty to resign from the trust at any point of time giving one month's prior written notice stating his intention to do so and in consequences of such notice, the board of trustee shall accept the same relinquishing his liability from the trust. The board of trustee shall fill up the vacuum of trustee by admitting new trustee in the special meeting of the trust.

19. General Meeting:

A. Annual General Meeting:

A General Meeting of the members of the trust shall be held once in a year at the office of the trust or at such other place and at such time as may be determined by the board of trustees. Such meeting will be called the Annual General Meeting of the trust. All general meetings other than Annual General Meeting shall be called Special General Meeting. The first annual general meeting shall be held within 15 months from the date of formation of the trust and thereafter once in a year but not more than 15 months shall elapse after the holding of the last Annual General Meeting. The date of execution of the trust deed be deemed for all effective purposes to be the date of formation of the instant trust.

B. Time of holding of Special General Meeting:

The Board of Trustees may whenever it thinks fit and it shall within seven days from the date of receipt of written requisition signed by not less than $2/3^{\text{rd}}$ of the members of the trust convene a Special General Meeting of the trust at a time and place to be fixed by the Board of Trustees to consider matters that may be placed before it by the Board of Trustees, or in the case of a requisition meeting such matters as may be specified in the requisition.

C. Business of Annual/Special General Meeting:

The business of the Annual/Special General Meeting shall be to receive, consider and place the report of the Board of Trustees on past years affairs, the accounts and balance sheet of the past year, the budget for the next year, if that is thought necessary, to appoint auditors and to transact any other business which is brought under consideration by the report of the committee. No other business shall be

transacted at an Annual General Meeting. The business of the Special General Meeting shall be to transact the business as have been specified in the agenda.

20. Powers, duties & functions of the President of the Board of Trustees:

The power, duties and functions of the President shall be as follows:

- (i) To open current and savings account/accounts with any Bank/Banks jointly with Secretary of the Trust and in the name of the Trust and operate and maintain the Bank account/accounts for the interest and benefits of the trust.
- (ii) To apply for loan on behalf of the trust in any Bank/Banks on such terms and conditions as may be agreed upon for the interest of the trust.
- (iii) To look after the general affairs of the trust;
- (iv) To preside over all meetings of the Board of Trustees;
- (v) To call for emergency meeting of the Board of Trustees, whenever necessary;
- (vi) To call for special meeting of the General Body, whenever necessary. It is further specifically laid down that the President shall have the voting right at any meeting of the Board of Trustees unless he becomes a member thereof and on matters of interpretation on any point, the President's ruling will be final.
- (vii) To exercise special powers for the greater interest and benefit of the trust.

21. Powers, duties & functions of the Secretary of the Board of Trustees:

The powers, duties and functions of the Secretary shall be as follows:

- (i) To conduct correspondences;
- (ii) To suspend, in cases of emergency, members of the salaried staff and place the matter forthwith to the Board of Trustees for confirmation;
- (iii) To carry on day to day administration of the trust and general management of the affairs of the trust;
- (iv) To convene meetings of the Board of Trustees and general meeting of the trust in consultation with the President;
- (v) To keep the minutes of all meetings of the Board of Trustees;
- (vi) To maintain inventory of all properties of the trust;
- (vii) To make and receive payments and give valid discharges on behalf of the trust;
- (viii) To open current and savings account/accounts with any Bank/Banks jointly with President of the Trust and in the name of the Trust and operate and maintain the Bank account/accounts for the interest and benefits of the trust
- (ix) To prepare budget for the financial year and place it before the Annual general meeting for its approval.
- (x) To start, defend, prosecute any legal action for the trust and appoint lawyer, sign vokalatnama on behalf of the trust subject to approval of the President;
- (xi) And generally to do everything for the proper management of the affairs of the Trust.

- (xi) And generally to do everything for the proper management of the affairs of the Trust.

22. Powers, duties & functions of the Treasurer of the Board of Trustees:

The powers, duties and functions of the Treasurer shall be as follows:

- (i) To keep proper accounts of receipts and expenditure;
- (ii) To make all payments regarding routine expenses and
- (iii) To prepare the Annual accounts and Balance Sheet under the guidance of Secretary and get them audited.

23. The trustees may time to time frame rules for the conduct and regulations of the meetings of the trustee. In the absence of such regulations :-

- (a) Two trustees shall forms a quorum for meeting of the trustee.
- (b) All matters will be decided by majority of votes by the trustees.
- (c) Resolution passed without any meeting of the trustees but by circulation thereof and evidence by writing under the hands of two - third of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of the trustees.
- (d) There shall be at least three meetings of the trustees during a calendar year.

24. The trustees shall have the power to determine, in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses outgoings ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents. Authority to discharge power:

The power of the Board of Trustees as enumerated herein above shall be discharged by the trustees of the Board; Provided, however any act, deed or thing required to be done or executed by the board of trustees including the drawing and signing of cheques and the endorsement of Government Securities shall be deemed to have done by all the trustees of the board, if it is done or executed by any one or more of the trustees in pursuance of a resolution of the board of trustees adopted in that respect.

25. The trustees shall be entitled to be paid all expenses actually incurred or that may have to be incurred by them as trustees in relation to the affairs of the trust. All donations, subscriptions, gifts and other money and property received by any office bearers of the trust or any member thereof shall forthwith be paid to the Board of Trustees.

26. Trustees' liability for the acts & defaults of co-trustees:

No trustee shall be liable and/or responsible in any manner whatsoever for the acts and defaults of co-trustees and that no trustee shall further be liable for any loss

caused to the trust unless the same has been caused by practicing fraud or willful negligence.

Mode of Dissolution of the Trust:

The trust hereby formed may be dissolved if the trustees of the trust unanimously agree to dissolve the same and that if upon dissolution of the trust, there remains any property after satisfaction of all its debts and liabilities whatsoever, the same shall not be paid to or distributed amongst the members of the trust or shall be given or transferred to some other trust to be decided by the trustees of the trust with the express consent of the President hereby formed.

27. It is expressly declared that no part of trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and law provisions hereof shall be considered accordingly. The trust hereby formed is purely a nonprofit making organization.
